1) What is your principle reason for running for the Board/President?

I am running for President to ensure that the voices of *all* our membership are heard. My experience with Sigma Tau Gamma is as extensive as it is broad. I've been a founding father, an advisor, a regional officer, a staff member, and now a director. I have a deep understanding and passion for our organization. My experiences have given me an honest and holistic knowledge of how the fraternity works at the local, regional, and national level. Serving on the Board of Directors has been a great privilege, and has allowed me to take the next step in my continued devotion to Sigma Tau Gamma as president. The opportunity to serve the organization I love and hold dear was the easiest decision I've ever made. If elected President, a longer term will allow me ample time to continue to work toward creating a better future for our fraternity, including values-based programming that exemplifies our principles and provides services to all of our undergraduate chapters in addition to alumni associations. Chapter expansion has proven critical in the growth of Sigma Tau Gamma over the past few years. Nonetheless, we need to provide support services and housing as needed to the great pre-existing chapter base. We must implement a plan that devotes the

necessary resources towards chapter service as well as growth.

We stand at the edge of an exciting time for Sigma Tau Gamma. We are an industry leader in recruitment and expansion. Our Path of Principles is an excellent member-education program that is steeped in our rich tradition and heritage. But most importantly, this Grand Chapter marks the beginning of new Executive leadership among the headquarters staff. Brother Bill Bernier will be transitioning out of his position as Chief Executive Officer after 40 years of diligent service. This is a defining moment, an opportunity that must be seized to forge new relationships with new leaders both inside and outside of our fraternity. Our centennial is around the corner, and I am dedicated to working with our new CEO to ensure another 100 years of success.

2) Sigma Tau Gamma, as a campus organization, competes in a crowded market for potential members; name two things Sigma Tau Gamma does well and two things we could do better?

It is no secret that Sigma Tau Gamma has quickly become the inter-fraternal leader in chapter expansion and membership recruitment. Partnering with Phired Up was a progressive and forward-thinking decision that resulted in a historical increase in chapters and membership. Expansion and recruitment are two areas where Sigma Tau Gamma has set the industry benchmark. However, this success cannot and should not come at the expense of existing chapters. We need to bring balance back to our operations as we move forward.

Consequently, the areas where we must strive to improve are continued chapter support and programming. We need to provide the necessary guidance and support to our chapters so they can operate more efficiently. Dedicating the necessary manpower and resources to chapter service is a necessity; because chapter service succeeds when carried out by professional headquarters staff members in conjunction with *trained* alumni volunteers. Further, with the founding of larger chapters at prominent Greek schools, the need for quality member housing is a growing concern. We must develop procedures to ensure that once chapters are established, they can be maintained with not only with personnel support but also built infrastructure. Integrating cutting-edge programming like Phired Up recruitment seminars and the Path of Principles into chapter support and expansion will result in fuller, more robust chapters that exemplify and practice the values of Sigma Tau Gamma.

3) What is the most important strategic priority for Sigma Tau Gamma Fraternity, Inc.?

Undoubtedly, the most important strategic priority for Sigma Tau Gamma is expansion. Over the past few years, we have reaped the benefits of a successful expansion program, and we continue to do so to this day. It has been said that a rising tide lifts all boats. I believe our hardworking and tireless expansion efforts benefit everyone. There is no secret formula for creating a successful organization. Sigma Tau Gamma does not need another grand idea or program. We must stay true to our ideals and ourselves. Another new governance model, grand vision, management craze may yield results, but only fleeting and unsustainable ones.

Continuing to grow Sigma Tau Gamma – in chapter number and chapter size – will provide the necessary capital resources to improve programs and services at all levels. Expansion leads to more revenue, which opens the door to investment in staffing. This in turn builds our personnel base for future expansion, freeing other personnel resources for service to existing chapters where needed. Increased income through growth will afford us the additional resources needed to tackle challenges that we face with chapter housing needs, alumni engagement, enhanced chapter involvement, and philanthropy. With successful focus on continued growth, we will have the ability to invest in various levels of organizational infrastructure, from provisional

chapters to alumni associations and everything in between.

4) What personal and professional experience do you bring to the Board of Directors?

As Director of Chapter Development for the Headquarters staff, I spent three years on the road working directly with our chapters, and conducted more than 120 chapter service visits.
